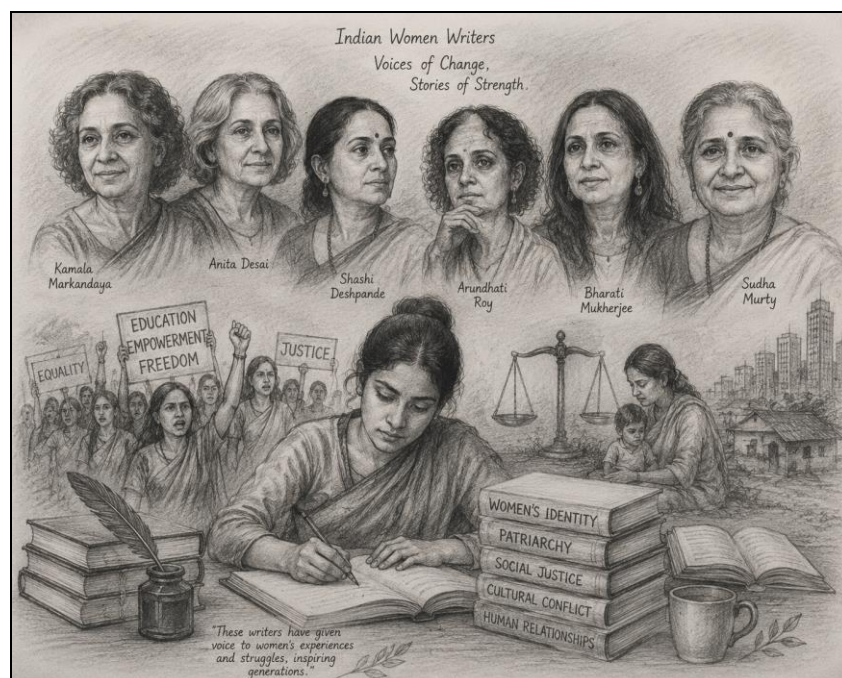


Fig 1: Representation of Indian women writers giving voice to women's struggles, patriarchy, and social reform through literature
